Biography

Rev. Kwok Nai Wang (郭乃弘 Guo, Naihong) was born in 1938. He was the youngest son of Ms. Pancy Leung (梁德芳) and Mr. Kwok Chung Yu (郭宗宇), the deacon of China Congregational Church. Rev. Kwok's siblings include Mr. Kwok Nai Hong (郭乃康), Ms. Kwok Sau Chun (Josephine Claessen 郭守真) and Mr. Kwok Nai Sik (郭乃適). He was married to Ms. Dorothy Louise McMahan in 1966 and they have a daughter named Michele Ming Ling (明玲) who was married to Mr. Albert J. Tong (唐子傑). Rev. Kwok and his wife Dorothy Louise divorced in 1973 and he was married to Ms. Man Wah Dorothy Wong (汪曼華) in 1993. Rev. Kwok has two grand-daughters named Katherine Halen Tong (唐晞蓮) and Elizabeth Haven Tong (唐晞芸)

Rev. Kwok graduated from the University of Hong Kong in 1963 and the Yale University Divinity School in the United States in 1966. He was ordained at the Centre Church on-the-Green at New Haven in the same year.

Upon returning to Hong Kong in 1966, Rev. Kwok became the pastor of Shum Oi Church, the Church of Christ in China in Shek Kip Mei until 1977 when he took up the post of General Secretary of the

Hong Kong Christian Council 香港基督教協進會 (HKCC). HKCC is an ecumenical body of Christian churches, organizations and institutions in Hong Kong. In 1988, Rev. Kwok resigned and founded the Hong Kong Christian Institute 香港基督徒學會(HKCI) with some Christians and pastors and he became the first director in September. HKCI is a platform to gather Christians with similar views to make contribution to society and the Church in Hong Kong. During the twenty-three years from 1966 to 1988, Rev. Kwok also took up other responsibilities and served in different Christian organizations. He was a part-time lecturer at the Chung Chi College 崇基學院, the Chinese University of Hong Kong from 1967 to 1973, the Director of the Hong Kong Christian Service 香港基督教服務處 from 1980 to 1988, the Chairman of the Executive Committee of Alice Ho Miu Ling Nethersole Hospital 雅麗氏何妙齡那打素醫院 from 1981 to 1982 and the Chairperson of Board of Directors of United Christian Medical Service 基督教聯合醫務協會董事會 from 1985 to 1987.

Rev. Kwok served at HKCI for twelve years and retired in 2000. Then he taught at the Lutheran Theological Seminary (LTS) for another 15 years. During this period, he also served as the honorary consultant for ministry with local congregations at Christian Conference of Asia (CCA) from 2002 to 2006, and held the post of senior minister at the Kowloon Union Church (KUC) from 2006 to 2008.

Rev. Kwok is a liberal and outspoken Christian leader who has been actively involved in the circle of the Christians, churches and Christian organizations. He has participated in various conferences and workshops related to Christianity, church development and evangelism. He also has immense interest in advocating the principles of human rights, church reform and Christian faith, justice, democracy and future development in Hong Kong. He participated in and sometimes initiated social and political action and movements for democracy, direct election, political reforms and human rights. Moreover, he has written tremendous number of English and Chinese articles in newsletters, newspapers, journals and books, and he also delivered speeches in different occasions such as church services, training workshops and conferences related to religious, social and political issues.

Rev. Kwok's strenuous efforts in his work and services brought him recognition from different organizations. He received the award of the Gamaliel Chair in Peace and Justice for his insistence for human rights and democracy in 1997, and the Lux et Veritas (Light and Truth) alumni award from the Divinity School of Yale University in 2010, an honor for its alumni "with demonstrated excellence and distinction in ministering with Christ like compassion".

General

The Kwok Nai Wang Papers document Rev. Kwok's career life as a pastor and head minister at churches, a Christian leader in various Christian organizations, as well as an educator in religion, church services and pastor training in Hong Kong. The collection also records his active participation, belief and concerns in some religious, social and political issues since the 1960s.

The collection contains articles, correspondence, clippings, lecture notes, manuscripts, photographs, agenda and minutes, reports, newsletters, speeches, conference materials, as well as journals and books, etc. Most of the materials were written by Rev. Kwok in his capacity as the leader in various Christian organizations and churches, editor and/or writer of different publications, and advocator and participant in some social and political events and movements. Rev. Kwok has also collected a huge number of Chinese and English clippings and documents on socio-political issues. In fact, this collection not only documents Rev. Kwok's career and interest, but also reflects the development and changes in churches, social and political conditions and development in Hong Kong between the 1960s and 2010s.

Rev. Kwok Nai Wang attended many conferences and often gave speeches and lectures in conferences, workshops, training courses, ceremonies and Christian events and activities in Hong Kong and overseas. Most of these activities and events were organized by Christian organizations such as the Hong Kong Council of the Church of Christ in China, Alliance Bible Seminary and Hong Kong Chinese Christian Churches Union. Rev. Kwok's lectures and speeches mainly focused on churches, ecumenism and Christianity, as well as society and justice. Folders 1-1 to 3-3 contain conference materials, photographs, Rev. Kwok's manuscripts, speeches and lecture notes that he had used in events such as Asian Ecumenical Workshops at the Christian Conference of Asia (CCA), and his two-week tour to Milwaukee, Wisconsin, U.S.A. as the Gamaliel Chair in Peace and Justice in 1997.

Hong Kong Christian Council

Scope and Contents

This series basically documents the work and achievements of the Hong Kong Christian Council (HKCC). HKCC is an ecumenical body of Christian churches, organizations and institutions in Hong Kong. Rev. Kwok was the General Secretary of HKCC from 1977 to 1988 and he has collected many HKCC publications and documents. HKCC's works and activities are well documented in HKCC Annual Reports (folders 3-5 to 4-1), the General Secretary's Reports and open letters (folder 5-2) as well as the General Secretary's reports to the Executive Committee (folder 5-3). HKCC's Chinese and English journals entitled Message, News and Views are contained in folders 5-4 to 6-2 and 6-6 to 7-3. Some of the articles written by Rev. Kwok are also contained in these publications. Folders 7-4 to 7-8 document some vital issues related to HKCC and the churches in Hong Kong. In his capacity of being the General Secretary of HKCC, Rev. Kwok played a leading role in organizing two important events called "Church Consultation – the Mission of the Church in Hong Kong in the 1980's" and "The Mission of the Church in Hong Kong – Mid-decade Consultation". Materials such as correspondence, posters, clippings and programs related to the consultations are included in folders 4-2 to 5-1 and 6-3 to 6-5. These materials document the participants' discussion on the role of the Church in democratic development, and the Christian community's reaction and preparation in response to the transfer of sovereignty in Hong Kong.

Hong Kong Christian Institute

Scope and Contents

Rev. Kwok founded the Hong Kong Christian Institute 香港基督徒學會 (HKCI) and served as the Director after he had resigned from the Hong Kong Christian Council in 1988. The Institute is a non-governmental organization campaigning for human rights and freedom in Hong Kong. HKCI Annual Reports are included in folder 8-1 while folders 8-2 and 8-3 contain documents on the formation and working plans of HKCI, Director's reports, as well as succession plan and farewell arrangement for Rev. Kwok's retirement in 1999. Rev. Kwok was the editor of HKCI bimonthly theological journal entitled Reflection for many years. This journal also covers topics on Christianity in relation to politics and society (folders 9-2 to 10-1). He also contributed some articles to the HKCI Newsletter (folders 8-4 to 9-1). His writings in these two publications (folders 8-4 to 10-1) covered various topics such as human rights, democracy, social and political issues in Hong Kong.

Hong Kong political system

Scope and Contents

Rev. Kwok is a liberal Christian leader who is dedicated to promote democracy, direct election, religious freedom and social justice in Hong Kong and he has been active in political activities and movements for decades. When the British government negotiated with the Chinese government on the future of Hong Kong in the 1980s, there was rigorous discussion among the Hong Kong people on Hong Kong's future political system and development, direct election, as well as the formulation of Basic Law. Rev. Kwok and many Christians were also very much concerned about these issues and therefore, actively discussed and expressed their concerns in different occasions. Rev. Kwok's manuscripts, interviews and correspondence, newspaper clippings, reports and documents in this series reflect the views and opinions of Rev. Kwok and some Hong Kong people on these issues.

Scope and Contents

After the British and Chinese governments signed the Sino-British Agreement in 1984, there was growing concern about brain drains and direct elections. In April 1989, a British Foreign Affairs Committee visited Hong Kong to study the situation and gather opinions from the Hong

Kong people. Clippings reporting the Committee's visit and correspondence lobbying the British MPs in this folder reflect different concerns of the Hong Kong people.

Scope and Contents

After the Tiananmen Square incident in June 1989, Hong Kong people had widespread worry about Hong Kong's future. The British government was also concerned about the impact on Hong Kong. Materials in this folder document some of these concerns. There are some Foreign Affairs Committee's minutes and report on Hong Kong to the House of Commons in regards to Hong Kong's future development and the situation after Tiananmen Square incident, some materials on Hong Kong People Saving Hong Kong Campaign 1989-1990 discussing the right of abode question, and a position paper on how to resolve the crisis and to encourage Hong Kong people to stay in Hong Kong.

Scope and Contents

This folder contains Hong Kong government reports on human rights and a United Nations Hearing Committee of Human Rights Report listing the concerns and recommendations on human rights in Hong Kong. Other documents include Hong Kong Christian Institute's correspondence with the Hong Kong government offices such as Legco and Home Affairs Bureau, as well as the United Nations High Commission for Human Rights. The correspondence is all about human rights. There is also a volume of submissions to the Human Rights Subcommittee of the Joint Standing committee on Foreign Affairs, Defence and Trade, Australian Parliament. These submissions discuss issues related to the transfer of Hong Kong's sovereignty, such as political systems and human rights.

Scope and Contents

Rev. Kwok was the senior pastor and mentor at the Kowloon Union Church (KUC) from 2006 to 2008. He helped form the corporate ministerium (corpus ministerium), a new form of ministry and he also planned for church services and administrative reforms at KUC. His proposals and work to introduce new plans at KUC are well documented in many of his correspondence, discussion papers, as well as the minutes and reports of the KUC Council (folder 11-4) and the KUC Corporate Ministerium Meetings and Ministerial Group meetings (folder 11-3). The notes he used in sermons at KUC are contained in folders 11-5 to 12-3.

Socio-political issues

Scope and Contents

Rev. Kwok's Chinese and English manuscripts, speeches, newspaper interviews, newsletters and journal articles that were published between 1966 and 2016 are included in this series. These English and Chinese materials basically reflect his concerns, views and recommendations on various local and overseas religious and socio-political issues. Major subjects discussed in the materials include church development, Bible study, democracy and direct election, political development and systems, human rights, education, anniversary of Tiananmen Square incident, freedom of speech, retirement scheme and social welfare, etc. This series also contain Rev. Kwok's speeches delivered in forums, conferences, churches and special events such as memorial services and graduation ceremonies.

Visits to China

Scope and Contents

The Chinese and British governments started a series of negotiations on the future of Hong Kong in 1982 and finally signed the Sino-British Joint Declaration on December 19, 1984. The two-year Sino-British negotiations resulted in lots of concerns and discussion among the people in Hong Kong. Religious freedom was one of the hot topics that the Christian community discussed actively. In August 1984, Rev. Kwok and some Christian leaders prepared the “Manifesto of the Protestant Churches in Hong Kong on Religious Freedom” and sent it to the Chinese government (Folder 23-6). In the following two months, Rev. Kwok joined a group of Christian leaders and a Hong Kong delegation to visit Beijing to discuss with the Chinese government officials their concerns on religious freedom and the future development in Hong Kong (folders 23-4 to 23-5).
